The Board of Brown County Commissioners met in regular session with the following members present: Chairman Warren Ploeger, Keith Olsen, and Steve Roberts. Also present were County Clerk Melissa Gormley and Deputy County Clerk Dawn Boyles. County Attorney Kevin Hill was present for a portion of the meeting. Warren Ploeger opened the meeting at 8:00 a.m.

SHERIFF

John Merchant, Brown County Sheriff, reported there are 12 inmates, 7 males and 5 females, currently at the Brown County Jail. Sheriff Merchant also presented a building permit to the Commissioners for their approval. The 16’ X 30’ storage shed will be located at the Sheriff’s Department. Motion by Steve Roberts to have Edelman’s construct the storage shed. Seconded by Keith Olsen. Motion carried. Merchant discussed the unofficial grant of \$37,920 that the Sheriff’s department has been awarded from the state. The grant will be for mobile data in the patrol cars.

IT DEPARTMENT

Sandy Carter, It Director, discussed with the Commissioners about the purchase of a new Sonicwall/firewall. The amount to purchase would be \$1,721and Carter has the funds in her budget to cover the purchase.
