Motion by Steve Roberts to proceed with the process to vacate approximately 1/8 mile of Linden Road, just south of 200th Street. Seconded by Warren Ploeger. Motion carried. A resolution will be passed at a future meeting.

SHERIFF

Lamar Shoemaker, Sheriff, discussed recent burglaries, drug cases and the redistricting of local fire districts.
