SERVICES FOR THE ELDERLY

Wanda Davis, Services for the Elderly Director, discussed her 2022 budget. Davis also discussed the hot meal program within her department. Brown County Clerk, Dawn Boyles, presented the three financing bids for a three year term for the District 3 backhoe. The bids were as follows: Bank of Blue Valley with an interest rate of 2.1% for an annual payment and 2.05% for a semi-annual payment; Citizens State Bank and Trust with an interest rate of .95%; and GN Bank with an interest rate of 2.29%. Motion by William Pollock to accept Citizen State Bank’s interest rate of .95%. Seconded by Lamar Shoemaker. Motion carried.
