The Board of Brown County Commissioners met in regular session with the following members present: Chairman Steve Roberts, Dwight A. Kruse and Keith Olsen. Steve Roberts opened the meeting at 8:00 a.m.

## SHERIFF

John Merchant, Brown County Sheriff, reported there are 26 inmates, 22 males and 4 females, currently at the Brown County Jail.

### **SHERIFF 911 SYSTEM**

Brown County Sheriff, John Merchant, discussed the state mandated Next Generation 911System. The State's bid is \$402,000 with the equipment being owned by the state. Commenco's bid is \$221,000 with the equipment being owned by the county. Merchant plans to use PSAP funds to pay for the system using a three to five year payment option. Motion by Keith Olsen to accept Commenco's bid at \$221,000. Seconded by Dwight Kruse. Motion carried.

## MOTOROLA

Brown County Sheriff, John Merchant, presented a quote from Motorola to upgrade the current radios for \$91,282.37 to stay up to date with the Next Generation 911 system. Motion by Steve Roberts to accept the quote. Seconded by Keith Olsen. Motion carried.

Brown County Sheriff, John Merchant, discussed the issues we currently have with mobile and portable coverage with our current towers. Merchant is looking into options.
