The Board of Brown County Commissioners met in regular session with the following members present: Chairman Warren Ploeger, Keith Olsen and Steve Roberts. Also present was County Clerk, Melissa Gormley. County Attorney, Kevin Hill, was present for a portion of the meeting. Warren Ploeger opened the meeting at 8 a.m.

#### SHERIFF

John Merchant, Brown County Sheriff, reported there are 16 inmates, 13 males and 3 females, currently at the Brown County Jail. Merchant updated the commission on current happenings at the jail. He also spoke with the commissioners about the purchase of a dog. The black lab will serve as a drug dog and a therapy/comfort dog. The dog will cost \$5500.00.

#### **SHERIFF**

Deputy Brandon Lowe gave notice to the County Commissioners that he was taking a new position at the Hiawatha Police Department. He stated his reason for leaving the county after five years is that the insurance with the county is too expensive for the family plan and the City of Hiawatha can provided better benefits for his family. Lowe stated that he has enjoyed his time with the county and he hopes the commissioners can find a way to improve the cost of insurance. The employee share of health insurance is \$13,791.48 per year.
