Brown County qualifies for the Emergency Watershed Program to help fix about 350 to 400 feet of stream bank. It is a federally funded 75% / 25% program through USDA with the county being responsible for 25%. Motion by Keith Olsen to sign a letter of interest for the program. Seconded by Steve Roberts. Motion carried.
