### **NOXIOUS WEED CONTRACT**

Motion by Warren Ploeger to renew the contract with KDOT for Brown County to treat noxious weed infested areas along State Highway rights-of-way within Brown County at a price of \$60 per hour. Seconded by Steve Roberts. Motion carried.

### **CONCEALED CARRY LAW**

Security in the Courthouse and the Concealed Carry Law were discussed. An Exemption to the Law had been in place in Brown County to not allow Concealed Carry Permit Holders to carry weapons into the Courthouse or County property. The exemption will expire January 1, 2014. It had previously been requested to have Security devices installed at the Courthouse entrance, with Security people manning the devices. Only one entrance would have been open to the public.

Motion by Warren Ploeger to take no action on the Concealed Carry Law and to allow the exemption to expire January 1, 2014, this will allow Concealed Carry Permit Holders to carry weapons into the Courthouse and other County properties. Seconded by Keith Olsen. Motion carried.
