Steve Winters, American Legion, reported that a Flag Burning Ceremony will be held on Sunday November 10, 2013 at 2 p.m. on the south side of the Brown County Courthouse. The ceremony is an honorable way to dispose of worn or badly soiled flags. The public is invited to attend. LANDFILL
