HORTON BUILDING COLLAPSE

Horton Mayor Tim Lentz reported on the collapse of a wall of an old building in Horton. Keith Olsen had offered to waive the fees for the collapsed building materials at the Brown County Transfer Station. Warren Ploeger was against the waiving of the fees, as the County has to pay the fee to have the material hauled off. Ploeger explained the material needed to be sorted for the C&D pit and Transfer Building. Keith Olsen stated that District 2 Road & Bridge had offered assistance in hauling the materials.

Motion by Keith Olsen to waive fees for the hauling of the collapsed building materials to the C&D pit of the Brown County Transfer Station. Seconded by Steve Roberts. Motion carried.

Motion by Steve Roberts to charge half price, which would be \$22, for any material going thru the Transfer Station Building. Seconded by Keith Olsen. Motion carried with Warren Ploeger voting nay.

SERVICES ELDERLY

Betty Kerns, Director of the Hiawatha Senior Citizens Center, discussed a possible move of the Senior Citizens location in Hiawatha. Kerns stated that after viewing the new location, the Senior Citizens had decided to stay where have been located in the American Legion Building. Sam Schuetz was also present for the meeting, as the American Legion representative.

JEFERSON COUNTY COMMISSIONER

Jefferson County Commissioner Richard Malm, representing the Kansas Association of Counties, reported on the map of Kansas which will be located in the renovated Capital Building in Topeka. Each county has been asked to raise \$1,000 to pay for their County's rock on the map.

Malm also discussed a multi-county meeting on the possible purchase of bulk products such as oil and salt, by a group of counties to reduce the cost.
