County Attorney Kevin Hill discussed the offer of Randy Fee to purchase two tracts left over from the last Tax Sale. Hill stated that one of the tracts was actually an Everest subdivision and should not have been on the Tax Sale. This error was made by the abstract company.

TRI-COUNTY MANOR

Lesa Duryea, Tri-County Manor Administrator, and Lori Gray, Services Elderly, discussed the need for a Meals on Wheels contract between Brown County and Tri-County Manor. Tri-County provides meals for the Meals on Wheels Program for south Brown County. Duryea and Gray will draw up a contract which will be reviewed by the Brown County Commissioners.
