SHERIFF

Sheriff John Merchant reported 25 inmates currently being held in the Brown County Jail.

MINUTES

COMPUTER/IT

Sandy Carter, Computer/IT Director, presented the Manatron annual software maintenance billing of \$35,351.55.

DISTRICT COURT CLERK

Joy Moore, District Court Clerk, presented the billing to Manatron for \$1,052 for a replacement computer.

TREASURER

Treasurer Cheryl Lippold reported that the Brown County Treasurer's office had received from the State of Kansas a 100% compliance audit for two months in a row. Lippold wanted to commend her staff for the 100% report.

Road Foreman Herb Roland requested that Commissioner Roberts view a worksite later in the day. Projects for the last week were discussed.

COMMUNITY CORRECTIONS

Motion by Steve Roberts to approve the hiring of Dan Siebenmorgen as Intensive Supervision Officer 1 at a rate of \$17.75 per hour. Seconded by Warren Ploeger. Motion carried.

PADONIA TOWNSHIP TREASURER

County Election Officer Debbie Parker reported that Jerry Reschke had been elected Padonia Township Treasurer as the result of a write-in vote in the November 6, 2012 General Election. Due to the fact that Reschke already holds the position of Padonia Township Clerk, he has declined the Treasurer position. The Padonia Township Board will need to make a recommendation for the Treasurer position to the Brown County Board of Commissioners so that they may make the appointment..

DOVES

Tessa Carter, DOVES (Domestic Violence Emergency Services), reported on the services of DOVES in the Brown County area. Carter requested financial assistance from Brown County as DOVES has received cuts in the financial assistance from both the State and Federal governments.

Motion by Warren Ploeger to approve a \$1,000 appropriation to DOVES from the Commissioner's Budget to be paid in 2012. Seconded by Keith Olsen. Motion carried.
