### JAIL FUND

Motion by Warren Ploeger to transfer the remaining bond monies from the Jail Account to the County's bond and interest fund so that the remaining money can be used to pay towards the jail bonds. There is a little over \$100,000 left in this account. Seconded by Keith Olsen. Motion carried.
