BRIDGE PROJECTS

Ron Seitz, KDOT, Norm Bowers, Local Road Engineer, and Tom Bennett, BG Consultants discussed the recent fracture critical bridge inspection mandates. Seitz stated that the bridge inspection laws have not changed in the past 20 years but are now being enforced more stringently. The fracture critical bridges only need to be inspected once every 24 months. Tom Bennett reported they were not aware of this. According to Seitz, federal monies could be withheld from the State of Kansas if the bridge inspections are not made.
