MOTION RESCINDED FOR BROWN COUNTY EMPLOYEE 2012 RAISES

In order to account for the difference in Health Insurance Premiums paid for by the County, a motion was made by Steve Roberts for a 25 cent per hour raise for employees who carry family or spouse insurance and for the Commissioners; and a 50 cent per hour raise for employees who are single or those who do not have health insurance with the County. Seconded by Keith Olsen. This will be effective for the first payroll in January 2012. Motion carried.
