PUBLIC HEARING RAILROAD CROSSING CLOSING

The Public Hearing for the Railroad Crossing Closing located at 250th and Kingfisher was held with Brown County residents Ken Pyle, Jack Schaffer, Larry Weast, William Pollock, Lori Gray and Dave Pfister in attendance. Commissioner Roberts reported there are currently an estimated 25 trains a day at this crossing, with double that amount of trains in the near future. According to KDOT an estimated 10 to 12 vehicles use this crossing daily. As a safety issue, the Commission and the Railroad feel it is best to close this crossing. Those speaking in opposition were Larry Weast, Ken Pyle, Jack Schaffer and Lori Gray, who all felt that safety arms at the crossing would be a better solution.

HEALTH INSURANCE

John Matalone of Matalone Insurance presented options on the County Health Insurance. Matalone discussed premiums on 12 different insurance plans. Matalone requested a special meeting this week to present more information.

RAILROAD CROSSING CLOSURE
