# SHERIFF

Sheriff John Merchant reported 19 inmates currently being held in the Brown County Jail. Last week's arrests were also discussed.

## COMMUNICATIONS TOWER

Deputy Doug Brammer reported that the City of Hiawatha responded to Brown County's request for the placement of the new Communications Tower. The City has requested a meeting with Commissioner Warren Ploeger, County Attorney Kevin Hill and Sheriff John Merchant to further discuss the tower. The City is concerned that the placement of the tower will cause the loss of \$375 income to the City of Hiawatha. Horton City Mayor Tim Lentz was present and stated that the Communications Tower could be placed on Horton City property if it would help the residents of Brown County.

## HORTON HOSPITAL

Terry Nichols, new interim CEO of the Horton Hospital, discussed changes recently made at the Horton Hospital. Some positions have been eliminated but plans for building the new hospital continue.
