The Board of Brown County Commissioners met in regular session with the following members present: Chairman Warren Ploeger, Steve Roberts and Keith Olsen. Also present was County Clerk Debbie Parker. County Attorney Kevin Hill was present for a portion of the meeting.

Warren Ploeger opened the meeting at 8:00 a.m.

SHERIFF

Sheriff John Merchant reported 23 inmates currently in the Brown County Jail. Merchant also reported on various arrests from the prior week. Sheriff Merchant also reported on the receipt of a \$2000.00 grant received from KCAMP, to be used for the purchase of 16 surveillance cameras. The total cost of the equipment will be \$2561.67 with Brown County paying the balance.

MINUTES

Motion by Steve Roberts to approve the May 28, 2010 Canvassing minutes for the May 25, 2010 USD 441 Consolidation Election. Seconded by Keith Olsen. Motion carried.

Motion by Steve Roberts to approve the May 28, 2010 regular session minutes. Seconded by Keith Olson. Motion carried.

APPRAISER

Paula Jones, County Appraiser reported on a software update with R&S Digital. There will be a one-time fee of \$800.00 for the upgrade from ArcIms to ArcServer. Motion by Warren Ploeger to approve this purchase. Seconded by Keith Olsen. Motion carried.

Jones also presented information to the Board on mobile homes. This information explained the difference between a mobile home classification and a manufactured or modular home. Neighborhood Revitalization Plans and applications were discussed. Motion by Steve Roberts to exclude all mobile homes from qualifying for NRP effective immediately, excluding those that are already active participating parcels. Seconded by Keith Olsen. Motion carried unanimously.

TREASURER

County Treasurer Cheryl Lippold, presented bids for a \$200,000.00 CD currently at Union State Bank. One bid was received from Union State Bank for 1.22% for 365 days. Motion by Keith Olsen to accept the bid. Seconded By Steve Roberts. Motion carried.

County Attorney Kevin Hill reported on the progress of the next tax sale.
