COURTHOUSE WINDOWS

The windows are being replaced as part of an ongoing project to maximize energy usage; a new heating/cooling system and a new roof have been added during the past few years. Former Extension Director Steve Brown estimated that a 30% savings could be realized with the installation of the new windows.

HOUSE BILL 28-23

Commissioner Warren Ploeger testified before the House Taxation Committee in Topeka on Friday March 14, 2008 in regards to House Bill 28-23. This bill, if passed, would allow Brown County to add a maximum 1 percent sales tax question on the November 2008 General Election Ballot to use for the construction of a new correctional facility. Sheriff Lamar Shoemaker also attended the hearing.
