## COURTHOUSE WINDOW TREATMENT BIDS

# WIND ENERGY UPDATE

Lynn Ladner, Hiawatha City Administrator, presented a Wind Energy update. Ladner and Steve Smith attended the American Wind Energy Conference in Houston, Texas last week. A study on wind energy potential in Kansas was discussed, with the potential wind energy in Kansas being much higher than expected. A company in Korea requested information on possibly locating a wind energy equipment company in Brown County, with construction beginning in the 3<sup>rd</sup> quarter of 2008. Three possible sites are being considered by the Korean company.

Ladner also reported that the City of Hiawatha did not receive the Second Phase Streetscape Grant.
