Bids to replace the boiler at the Brown County Jail were reviewed. Bids were given on a MLX 606 90% High Efficiency Boiler. Since the bids were not submitted for the same scope of work, Commissioner Ploeger analyzed them closely to try to determine the best value. It was decided that the County would remove the old boiler system saving \$3800.00 off the bid of \$43, 399.00 by Waldinger's. A motion was made by Steve Roberts to accept Waldinger's bid for \$39,599.00. Seconded by Glen Leitch. Motion carried. McElroy's bid of \$39,310.00 did not include the same equipment or scope of work. Head Custodian Buzz Siebenmorgen was also present for the boiler discussion.
