# **COUNTY ATTORNEY**

Kevin Hill reported on the Keystone pipeline project and the possibility of it being a taxable project. If the project that runs from Nebraska is not 190 miles long it could become a taxable project. There are several determining factors to be considered before the final decision will be made on this project. Kevin was authorized by the Board to pursue the taxable status of the pipeline extension that will run through Brown County.

# **COUNTY ATTORNEY**

County Attorney Kevin Hill requested that the Board of County Commissioners combine the positions of County Attorney and the Assistant County Attorney into one position; this would eliminate the Assistant County Attorney's position. Hill would resign from his partnership with Finley, Miller & Cashman and establish his office in the Courthouse. Hill would bring one full time secretary with him. He is asking the Board to vacate the office now utilized by NEK-CAP; the office is currently only open 14 hours per week. Motion by Glen Leitch to eliminate the assistant county attorney position and combine the salaries to set the County Attorney's salary at \$70,000 per year and the secretary's pay will be set at \$12.75 per hour to be effective January 1, 2009. Seconded by Warren Ploeger. Motion carried.

Motion by Steve Roberts to send notification to Nek-Cap today, requesting NEK-CAP to vacate their office space by December 19, 2008. Seconded by Glen Leitch. Motion carried.

#### JCAB/ACC

Venice Sloan, JCAB/ACC Director, submitted Adult and Juvenile Quarterly reports for signatures. Motion by Warren Ploeger to approve the memorandum of understanding between Juvenile Services, Brown County and 22<sup>nd</sup> Judicial District. Seconded by Glen Leitch. Motion carried.
