HIAWATHA TOWNSHIP ROAD CLOSING

Hiawatha Township Board Members David Pfister, Mark Schmitz and Wayne Knabe were present for a discussion of the Union Pacific Railroad's request to close a portion of Kingfisher Road north of Hiawatha. Also present were Brown County residents Steve Wilson, Jerry Reschke and Ed Hageman. Commissioner Roberts reported that the Union Pacific Railroad would have to spend between \$600,000.00 to \$750,000.00 to meet KDOT requirements of crossing lights, flashers and cross arms at the double rail railroad crossing. The Union Pacific has offered \$50,000.00 with a possible \$50,000.00 match from KDOT to aid in closing the road.

Pfister questioned whether the proposed Bio-Diesel plant near Padonia had anything to do with the road closing. Wilson stated that there is no question that this is a dangerous railroad crossing.
