#### SHERIFF/911 BUDGET HEARING

Sheriff Lamar Shoemaker discussed the proposed budgets for 2008. The Sheriff's budget is divided into three departments with the requested budgets as follows: Office at \$474,977; Dispatch at \$172,335; and Jail at \$285,322.

The 9-1-1 requested budget for 2008 is \$80,880.

## DISTRICT COURT/4-COUNTY HEARING

District Court Clerk Lela Smith presented the District Court 2008 proposed budget of \$78,630. Judge James Patton presented the total 4-County District Court 2008 proposed budget of \$41,000, with Brown County's share at \$10,791.

#### APPRAISER BUDGET HEARING

Appraiser Tom Brown discussed the 2008 proposed budget of \$150,100 for the Appraiser's Department. Brown requested permission to install a parcel search public access program with an annual contract per person which would allow appraisers to view information from the Appraiser's office online. The program would be purchased from Infinitec at a cost of \$4,415.00. Motion by Warren Ploeger to allow installation of the program. Seconded by Glen Leitch. Motion carried.

### COUNTY ATTORNEY BUDGET HEARING

County Attorney Kevin Hill presented the County Attorney 2008 proposed budget of \$104,775.

### AMBULANCE BUDGET HEARING

Town & Country Ambulance owner Jim Reigle discussed their proposed budget of \$47,500. Horton Ambulance Representative Joe Middleton discussed their proposed budget of \$63,320. The total proposed ambulance budget is \$110,820.

#### HEALTH DEPARTMENT BUDGET HEARING

Health Department Director Karla Harter and Cindy Cluck presented the proposed 2008 budget of \$50,078.

### EMERGENCY PREPAREDNESS BUDGET HEARING

Emergency Preparedness Director Steve Brown discussed the 2008 proposed budget of \$15,040.

### EXTENSION BUDGET HEARING

Extension Director Steve Brown and Board Member Jeff Grimm presented the 2008 proposed budget of \$87,960.

#### BCDS BUDGET HEARING

Brown County Developmental Services Director Linda Lock discussed the proposed 2008 budget of \$27,052.

## KANZA BUDGET HEARING

KANZA Director David Elsbury showed a short video on Mental Health and its function throughout the state. KANZA requested allocations of \$80,000 from Brown County for the 2008 budget.

### **GILMORE & BELL**

Keith Cowan, of Gilmore & Bell, discussed various financing options in regards to a possible new correctional facility in Brown County. Also present for this discussion were Sheriff Lamar Shoemaker and County Attorney Kevin Hill. The need for creating a Public Building Commission for Brown County was discussed.
