The Board of Brown County Commissioners met in regular session with the following members present: Warren Ploeger and Glen Leitch. Also present were County Clerk Debbie Parker and Deputy County Clerk Marla Hathhorn.

Commissioner Warren Ploeger opened the meeting at 7:45 a.m. Commissioner Steve Roberts joined the meeting at 7:55 a.m.

## **RESCUE SQUAD**

Rescue Squad President Jason Pavlish reported on the possible purchase of a 1989 rescue vehicle from Hebron Nebraska at an approximate price of \$35,000.00. The Commissioners requested that Pavlish review the Rescue Squad's finances and report back.

## SHERIFF

Sheriff Lamar Shoemaker reported on a rollover accident north of Horton during the last weekend. Shoemaker also discussed the first steps in the construction of a new correctional facility. Motion by Warren Ploeger to pursue the investigation of the construction of a new correctional facility.

Seconded by Glen Leitch. Motion carried. Motion by Warren Ploeger to retain Gilmore & Bell as the bonding agent for the construction of the new

correctional facility. Seconded by Glen Leitch. Motion carried.

Motion by Warren Ploeger to authorize Gilmore & Bell to establish a six member public building commission, with each Commissioner recommending two potential members to be appointed to the building commission. Seconded by Glen Leitch. Motion carried.

## SERVICES FOR THE ELDERLY BUDGET HEARING

Services for the Elderly Director Steve Ward presented the proposed 2008 Services for the Elderly Budget of \$164,565, less reimbursements of \$50,514, resulting in a total budget of \$114,051.

## NOXIOUS WEED BUDGET HEARING

Noxious Weed Director George Bruning discussed the proposed 2008 Noxious Weed Budget of \$132,100.

## **RESCUE SQUAD**

Rescue Squad President Jason Pavlish reported that the Rescue Squad has available funds of approximately \$2,000.00. Motion by Glen Leitch to authorize the Rescue Squad to make an offer of \$33,000 on the rescue vehicle previously discussed. Pavlish phoned the vehicle owner, who accepted the offer. Motion by Glen Leitch to approve the expenditure of \$33,000.00 for the purchase of a 1989 rescue vehicle, to be paid from the Commissioner's fund. Seconded by Warren Ploeger. Motion carried.

#### **CENTURY HEALTH**

Lisa Welch, Century Health, presented the Brown County employee insurance quarterly review for 2007. Both medical and dental quarterly claims were reviewed.

#### TREASURER BUDGET HEARING

Treasurer Cheryl Lippold presented the proposed 2008 Brown County Treasurer Budget of \$177,288. Lippold reported that Fraud Training is now required for all employees issuing Kansas Driver's licenses. The training is scheduled for August 22 and 23, 2007. The Commissioners suggested that Lippold notify the public of the closing of the Treasurer's office for one day for the mandatory training, so that all employees could attend the training.
