## STREETSCAPE COMMITTEE

Hiawatha City Administrator Lynne Ladner and Streetscape Committee members Steve Smith and Michael Schmitt were present to discuss the Phase 2 Downtown Streetscape Improvements. A probable project cost from BG Consultants for improvements around the Courthouse Square was estimated at \$217,000.00. Commissioner Ploeger requested information on what would be included in the Courthouse portion of the project. Ladner will gather the requested information for the Commissioners.
