SHERIFF

Sheriff Lamar Shoemaker reported that inmate transport expenses for this year have totaled \$25,000.00, with two months remaining in 2007. Also discussed were vehicle thefts and a train/truck collision. Emergency Management Director Jennifer Ploeger and Shoemaker discussed grants for Hazardous Mitigation Plan and County Personnel ID's.

DIESEL GENERATOR

Commissioner Steve Roberts reported on the purchase of a diesel generator from Capital Equipment Company at a cost of \$5,900.00. Included in the deal was a gas generator, air compressor and a pressure washer.

COURTHOUSE MEMORIAL

Commissioner Steve Roberts has been contacted by Terry Jimeson of the Legion Riders regarding a memorial to military POW's and those Killed in Action. The memorial would be designed by an architect and possibly be placed on the north side of the Courthouse.

BROWN COUNTY FAIR BOARD

Motion by Warren Ploeger to approve the appointment of Dusty Wenger to the Brown County Fair Board from District 3. Seconded by Glen Leitch. Motion carried.

COUNTY CELL PHONES

County provided cell phones are considered a taxable benefit by the IRS. Options for employee use of County cell phones were discussed. One option is to pay employees a stipend towards the employee's own cell phone. No decision was made.

KEYSTONE PIPELINE UPDATE

Jim Prescott, Keystone Pipeline, presented an update on the Keystone Pipeline Project. The pipeline will be approximately 2,200 miles long. The regulatory process/land easement part of the project has been worked on for the past 2½ years. The pipeline will run through three provinces in Canada as well as North Dakota, South Dakota, Nebraska, Kansas, Oklahoma, Missouri and Illinois in the United States. Construction will begin in 2008 with the pipeline arriving in Brown County sometime during 2009. Brown County land acquisition will begin later this year and continue through 2008. The Keystone pipeline will closely follow the Rockies Express Pipeline currently in Brown County. Various members of the public were present for the update.

BG CONSULTANTS

Tom Bennett, BG Consultants, presented Project #7C-4212-01 mylar map for signatures. Also discussed possible funding for repairs on Old 36 Highway east of Hiawatha.
