# **SHERIFF**

Shoemaker reported on the hospitalization on two additional inmates in the last month.

County cell phone options were again discussed. A possible stipend to the employee's payroll check would increase the employee's taxable benefit.

# YATES AVENUE

Horton City Administrator Levi Henry discussed the Yates Avenue agreement between Brown County and Horton City.

Henry questioned the agreement regarding ditch maintenance and the relocation of utility lines. Henry stated that a Horton City Commissioner would like to see the Yates Avenue project wait until after the Mission Lake dredging project is completed. Commissioner Roberts stated that he would rather drop the entire project as it was becoming so complicated.

The present Brown County Commission, because of the cash basis law, cannot commit to the project beyond 2008.

# SOLID WASTE

Solid Waste Director Charlie Brockhoff reported on a recent meeting he had attended on responding to a disaster. Various other issues at the Landfill were discussed.

#### ROAD FOREMAN

Road Foreman Darrin Matthias requested permission for the purchase of a used chain saw. Permission was granted.

#### **BROWN COUNTY EMPLOYEE INSURANCE**

Lisa Welch, Century Health Solutions, reported that Principal Financial Group had no increase for Delta Dental insurance or for the life insurance. Health insurance for 2008 will have a 1% decrease, with no changes in the flex fees.

Motion by Warren Ploeger, that after reviewing the proposals from Blue Cross/Blue Shield and Principal Financial Group, to renew the 2008 Brown County employee insurance with Principal Financial Group. Seconded by Glen Leitch. Motion carried.
