### **SHERIFF**

This will save on prisoner transport as the Brown County Sheriff's Department, the Courtroom, KANZA and the state hospitals will all be connected via tele-video. Shoemaker also reported an 80% decrease in meth labs since the new Kansas meth law went into effect.

### NEIGHBORHOOD REVITALIZATION HEARING
