### **SHERIFF**

Sheriff Lamar Shoemaker reported he has purchased a power washer for use in the cells at the jail. Also discussed was the smoking policy at the jail in regards to the inmates. The United States Immigration policy was discussed.

### **GIS SYSTEM**

Sheriff Lamar Shoemaker and Appraiser Tom Brown discussed the GIS System, which may be finished by August. The GIS System will help the Sheriff's Office with the County's 9-1-1 system and will also be used by the Appraiser's Office.

Brown discussed the naming of roads, going in alphabetical order from west to east and numbered roads starting with the lowest numbers at the south end of Brown County. In 1994 a plan was proposed but a Resolution was never passed in regards to the road naming standards. Following the progressive order would be very helpful to the Sheriff's Department and the 9-1-1 System. County Attorney Kevin Hill will be contacted to draw up the Resolution.

### **APPRAISER**

Appraiser Tom Brown discussed the 2005 Compliance Ratio Study.

### **TREASURER**

Treasurer Cheryl Lippold suggested that the oiling road crew use a flagman, especially while at a hilltop. Lippold also requested a stop sign at 260<sup>th</sup> & Kingfisher Roads. The Commissioners will look into the requests.

### **EXTENSION**

Extension Agent Steve Brown presented the latest statistics on fiscal conditions & trends in Brown County in 2006. Brown also reported on the Geo-Caches contest held during Hiawatha's Summerfest on June 24, 2006.
