BIO-ENERGY

Bio-Energy Representatives Steve Smith, Crosby Gernon, Terry Reschke, Gene Hillyer, Chuck Bebermeyer, Victor Menold and Bob Henry presented a letter of understanding between Brown County and Northeast Kansas Bioenergy, LCC. Steve Roberts would like to see a consolidated 5-year tax break instead of the proposed 10-year plan. The Bioenergy group was not opposed to the 5-year plan. The State Board of Tax Appeals allows for a 10-year plan. The County can only recommend to approve the plan. Warren Ploeger feels the 10-year plan would be best for the group. The group discussed an exploration of water project with the City of Hiawatha. The water supply for the City of Hiawatha would not be jeopardized. Also discussed was the consumption of natural gas, sewer and electricity. The Railroad commitment decision will be made on August 21. The group foresees the area becoming an industrial park with another business already expressing interest in the area.

NEK/SEN

NEK/SEN (Northeast Kansas/Southeast Nebraska) Representatives Gary Edelman, Bob Scoby, Doug Allen, Dan Kopp, Bryan Poppe, Wayne Grimm, Kirk Grimm and Mark Edelman; and RDA Representative Virginia Dienstbier, presented a letter of understanding between Brown County and NEK-SEN Energy, LLC. An Economic Development Loan Grant was discussed. Steve Roberts questioned why the Bioenergy Group and the NEK-SEN Group cannot be combined. A proposal to combine the groups will be reviewed by NEK/SEN this afternoon. Water, sewer, electricity, natural gas and the railroad was also discussed.
