# RICHARDSON COUNTY NEBRASKA

Richardson County Nebraska Commissioner Rex Jones stated that the Richardson County Commissioners are impressed with the condition of Brown County Roads. Richardson County has no chip and sealing equipment and therefore contracts out the chip and sealing. Jones requested that Brown County consider the options of the Brown County Road Crew contracting to chip and seal the Richardson County roads or contracting to use Brown County's equipment. The Brown County Road Foremen Herb Roland, Richard Geiger and Mel Werner were present for the discussion. Legalities and insurance liabilities will be looked into before making a decision.
