The Board of Brown County Commissioners met in regular session with the following members present: Chairman Warren Ploeger, Steve Roberts and Glen Leitch. Also present were County Clerk Debbie Parker and Deputy County Clerk Marla Hathhorn. County Attorney Kevin Hill was present for a portion of the meeting. Warren Ploeger opened the meeting at 8:00 a.m.

**SHERIFF**

Sheriff Lamar Shoemaker presented a contract between Johnson County and Brown County for the housing of Johnson County inmates in the Brown County Correctional Facility. Shoemaker also discussed bids being taken for Sheriff Department vehicles.

**TREASURER/REGISTER OF DEEDS**

Treasurer Cheryl Lippold and Register of Deeds Sandy Carter requested permission for the 2<sup>nd</sup> Floor Courthouse Offices to close for business at 4:30 p.m. Monday through Friday. Lippold explained that overtime pay would be reduced as her office could balance the end of day business after the 4:30 closing, with employees remaining until 5:00 p.m. Motion by Glen Leitch to close the 2<sup>nd</sup> Floor at 4:30 p.m. effective March 1, 2005. Seconded by Steve Roberts. Motion carried.

**OLD US HIGHWAY 36**

USD 415 7<sup>th</sup> grade students Larissa Schilling, Angel Mendez and Molly Brobst presented information on high-speed accidents on old US Highway 36, east of Hiawatha. The students requested speed limit signs be posted. Steve Roberts stated that Brown County blacktop roads are not posted, as it is common knowledge that the speed limit is 55 mph on such roads. However, due to the students concerns, speed limit signs will be

considered and Sheriff Shoemaker will be requested to increase patrols to enforce the speed limit on road.

Hiawatha City Mayor Leon Trant reported on the Welcome Home Parade for the returning local National Guardsmen, held Saturday February 12.
