The material cost was \$1.45 per gallon with an additional freight cost of .18, making the total cost of \$1.63 per gallon. All were in agreement that this material would not be cost effective at this time.

Nancy Gafford, RDA administrator presented the Heritage Trust Grant Application for the Brown County Historical Museum's heating system. The application was approved and signed. Also signed was a letter of support for the project. Various other community projects were discussed.
