The Board of Brown County Commissioners met in regular session with the following members present: Chairman Warren Ploeger and Steve Roberts. Also present was County Clerk Debbie Parker and Deputy County Clerk Marla Hathhorn. Warren Ploeger opened the meeting at 8:00 a.m.

SHERIFF

Sheriff Lamar Shoemaker reported that in the future the Hiawatha City tornado sirenwarning device would be sounded when a tornado warning is issued for Hiawatha City. The siren policy was changed due to complaints that the siren had not been used when the recent F2 tornado was on the ground for 3 miles south of Hiawatha. Shoemaker also discussed KANZA transports and a possible replacement for Memo the drug dog, who was recently injured.

JCAB/ACC

Venice Sloan, JCAB/ACC Director, reported that Adult Community Corrections employee Pat Carlton has resigned, effective June 24, 2005. Also discussed was the severe problem of placing juveniles on the weekends.

MAPLE HEIGHTS

Lesa Duryea, Maple Heights Nursing and Rehabilitation Center, requested that Maple Heights be placed back on the not-for-profit tax-exempt status list. Maple Heights was recently removed from tax-exempt status, after having been on the list since 1999. Appraiser Tom Brown reported that he was waiting for the ruling from County Attorney Kevin Hill.
