#### **ROCK BID OPENING**

Road Foremen Mel Werner and Richard Geiger were present for the Rock Bid Opening for 15,000 ton of rock for the 3 Road Districts. Bids were as follows: Bromley Quarries with a bid of \$7.90 per ton for all 3 districts; Servaes Brothers with a bid of \$8.35 per ton

for only District 2; and Martin Marietta with a bid of \$10.65 per ton for all 3 districts. Motion by Glen Leitch to accept the Bromley Quarries bid of \$7.90 per ton for all 3 districts. Seconded by Steve Roberts. Motion carried.

#### **BURIED CABLE PERMIT**

Buried cable permit #05-13 for Sprint was approved and signed.

#### **RAILROAD UPGRADES**

Letters were received from the Kansas Department of Transportation regarding three railroad crossing upgrades in Brown County. Agreements on the crossings will be signed at a future date.

#### **TAX CHANGE ORDERS**

Tax change orders #04-149 and #04-150 were approved and signed.

#### **CD BID OPENING**

Treasurer Cheryl Lippold was present for the bid opening of a \$500,000.00 CD with \$300,000.00 currently held at Farmers State Bank and \$200,000.00 currently held at Union State Bank. The bids were as follows: Citizens State Bank with a bid of 3.04% for 365 days; Farmers State Bank with a bid of 3.65% for 180 days and a bid of 3.86% for 365 days; Hiawatha National Bank with a bid of 2.79% for 180 days and a bid of 3.10% for 365 days; Morrill & Janes Bank with a bid of 3.59% for 180 days and a bid of 4.02% for 365 days; Silver Lake Bank with a bid of 3.40% for 180 days and a bid of 3.80% for 365 days; and Union State Bank with a bid of 4.07% for 365 days.

Motion by Glen Leitch to accept the Union State Bank's bid of 4.07% for 365 days. Seconded by Steve Roberts. Motion carried.

#### **WALKING/BIKING TRAIL**

Motion by Glen Leitch to sign a letter of support for Hiawatha City's proposed Walking/Biking Trail. Seconded by Steve Roberts. Motion carried.

#### **HEALTH DEPARTMENT**
