Also present was County Clerk Debbie Parker and Deputy County Clerk Marla Hathhorn. County Attorney Kevin Hill was present for a portion of the meeting. Glen Leitch opened the meeting at 8:00 a.m.

SHERIFF

Lamar Shoemaker, Sheriff, reported on the sale of two car forfeitures; the cars will either be sent to auction or put up for sealed bids. Also discussed was the riding of 4-wheelers by children.

Motion by Steve Roberts to rescind the motion made on June 7, 2004, which granted Dispatcher Donna Oldridge three days leave without pay. Due to accumulated comp time, Oldridge will not need the leave without pay. Seconded by Warren Ploeger. Motion carried.

JCAB

Venice Sloan, Director, and Steve Davies, JCAB Board President, reported a budget cut of \$20,000.00 to Community Corrections from the State of Kansas. However, there will be an increase to the 123 Fund Grant, which should help compensate for the Community Correction budget cut.

USD 430 MOCK ELECTION

Students 16 years of age and older will also be able to work with the election board at polling places in the upcoming elections.
