#### **EXCAVATOR**

Road Foremen Herb Roland and Mel Werner discussed hydraulic excavators. Motion by Warren Ploeger to purchase from Martin Tractor a 320 CL Hydraulic Excavator, with a trade-in of a 320BL Caterpillar, with a total cost of \$148,152.00 minus trade-in value of \$88,750.00, for a final cost of \$59,402.00

Sheriff Lamar Shoemaker discussed recent vehicle accidents.

#### **ROAD FOREMEN**

Road Foremen Herb Roland, Richard Geiger and Melvin Werner were present to discuss salt and chat storage. Dave Tannahill, Heartland Coverall presented information on soft storage buildings. The buildings have a 20-25 year warrantee.

### **CENTURY HEALTH**

Lisa Welch, Century Health, reported there will be a 9% increase for Brown County employee health insurance coverage for 2005. Different options for health and dental coverage were presented to the Commissioners, who will make a decision within the next two weeks. There are 59 employees and 27 families on the current plan.

### **BLUE LAB**

Janet Blue, Blue Lab, presented prices, services, and references for alcohol/drug testing with her company. She has a mobile unit, which would travel to the employee worksite. Motion by Warren Ploeger to accept Blue Lab as the Brown County alcohol/drug testing company. Seconded by Steve Roberts. Motion carried.
