ROBINSON COUNCIL TIE-BREAKER

The April 1, 2003 General Election produced a tie between Sharilyn Gilbert and Jack Allen for a position on the Robinson City Council. Motion by Warren Ploeger to break the tie by the flip of a coin, according to Kansas State Statue #25-3103. Seconded by Steve Roberts. Motion carried. The coin landed tails up, meaning that Jack Allen will fill the 5th position on the Robinson City Council.
