The Board of Brown County Commissioners met in regular session with the following members present: Glen Leitch, Chairman, Warren Ploeger and Steve Roberts. Also present was County Clerk Debbie Parker and Deputy County Clerk Marla Hathhorn. County Attorney Kevin Hill was present for a portion of the meeting.

Glen Leitch opened the meeting at 8:00 a.m.

SHERIFF

Lamar Shoemaker, Sheriff, reported that the new patrol truck had arrived. Also discussed was the part-time employee wages and cross-training between departments. Current investigations include a theft and a meth lab in Hiawatha City. New employee Corey Lay was introduced to the Commissioners by Shoemaker.

K-DOT PROJECTS

A letter from K-DOT informed the County of upcoming projects in Brown County. The first project will be a Bituminous Seal on K-20 between US Hwy 75 and the west Horton City limits; the start date will be June 17, 2003 and will be completed approximately June 30, 2003. The second project will be a Cold Recycle of the surface, Bitumimous Overlay and pavement markings on US Hwy 73 between the south Hiawatha City limits and the north Horton City limits. The start date will be August 1, 2003 and be completed approximately October 15, 2003.

MAYOR-ELECTS

Dale White, Horton City Mayor-Elect, and Leon Trant, Hiawatha City Mayor-Elect, discussed cooperation between the County and the cities. County wide law enforcement was discussed, with all parties wanting to explore options.
