Emergency Manager Don Pounds, presided and called the meeting to order.

COVID-19 review. Robin Downard gave an update on COVID-19. She stated Brown County has seen a big increase. There has been 230 total cases. Of those, 39 are active, 0 hospitalized, and 5 deaths. Downard stated the schools were doing a good job in keeping the kids safe. Vaccines are to come out in phases. With the healthcare workers and elderly to be in the first round of vaccines, then it will be available to the general public. Downards' advice is to wear masks. Pounds did a neighboring county comparison. Junker asked about the numbers of COVID cases and how they were counted. Kristine Romine stated the Health Department numbers are the most accurate.

Pounds reported on an anhydrous ammonia leak located at 270th and Coyote Road that occurred at 7:05 p.m. on 10-6-2020. Pounds described the action taken by emergency personnel, and overall the incident took about 30 minutes.

Curtis Stahal discussed new rules being put into place for the risk management program. Ag Partners will begin to implement the new rules in 2020 and they have until 2026 to get it done. He discussed the packets which included the emergency plan and contacts, safety data sheets, worst case scenario map, table top exercise, site visit invite, and site visit conducted. John Calhoon would like educational material given to dispatchers. Jeremy Forkenbrock stated it is key for dispatch to know EMT does not have the proper gear, but fire departments do.
